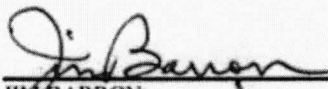

JULY REPORT**

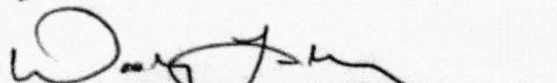
