NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$0.758948 per \$100 valuation has been proposed by the governing body of YOAKUM COUNTY.

PROPOSED TAX RATE \$0.758948 per \$100
NO-NEW-REVENUE TAX RATE \$0.758948 per \$100
VOTER-APPROVAL TAX RATE \$0.788944 per \$100

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for YOAKUM COUNTY from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval rate is the highest tax rate that YOAKUM COUNTY may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that YOAKUM COUNTY is not proposing to increase property taxes for the 2020 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 14, 2020 at 4:30 PM at DISTRICT COURTROOM.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, YOAKUM COUNTY is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting YOAKUM COUNTY of YOAKUM COUNTY at their offices or by attending the public meeting mentioned above.

The 86th Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by YOAKUM COUNTY last year to the taxes proposed to be imposed on the average residence homestead by YOAKUM COUNTY this year.

Tax on average homestead	\$490	\$549	12% increase
