Early Voting for “All” Elections (Including Democratic and Republican Primaries and Run-offs).

Early Voting will be conducted at two locations: The County Clerk’s office, in the Courthouse at Plains, Avenue G. and Cowboy Way, and the Denver City Community Building, 501 W. 15th Street, Denver City. Registered voters in Yoakum County may vote at either location, this is during early voting only. The office hours for Early Voting, will be 8:00 a.m.-5:00 p.m. (No weekend or extended late voting will be required, due to county size and population.)

Polling Precincts on Election Day-in Denver City (All Elections including Democratic and Republican Primaries and Run-offs).

Election Day Voting will be conducted at two locations: The Plains Community Building and the Denver City Community Building. Election Day voting is for one day only and you must vote in your precinct location, either Plains or Denver City. The hours for Election Day voting will be 7:00 a.m.-7:00 p.m. Below is a list of precincts and their location on Election Day:


