

Property (including any improvements):

TRACT ONE: Lots 9 and 10 and the East 4 feet of Lot 8, Block 24, original Town of Seagraves, Gaines County, Texas.

TRACT TWO: A tract of land 150 feet by 206 feet out of Section 112, Block T, D. & W. Ry. Co. Survey, Terry County, Texas and being described by metes and bounds as follows:

BEGINNING at a 1/2 inch steel rod set in the West right-of-way of U. S. Hwy. 62 and 82, for the NE corner of this tract, that bears West 50 feet and South 1787.10 feet from the NE corner of Section 112;
