Before me, the undersigned authority, on this day personally appeared Deputy Frank Rodriguez, who after being by me duly sworn deposes and says:

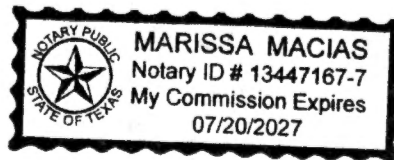
