The Department of the Air Force (DAF) is issuing this notice to inform the public of the availability of the *Final Environmental Impact Statement (EIS) for the B-21 Main Operating Base (MOB) 2 or MOB 3 Beddown at Dyess Air Force Base (AFB), Texas or Whiteman AFB, Missouri*. The publication of the Notice of Availability in the Federal Register on May 24, 2024, begins a 30-day waiting period before a Record of Decision can be signed.
