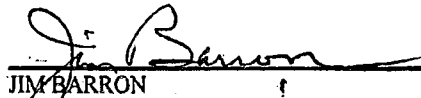

OCTOBER REPORT**

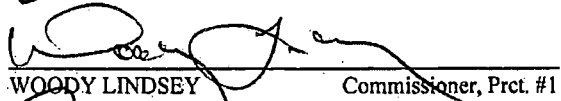
