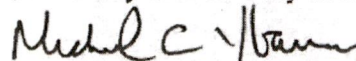

JULY REPORT**

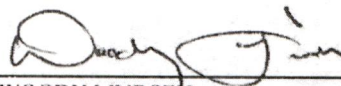

RAY MARION Commissioner, Prct. #2



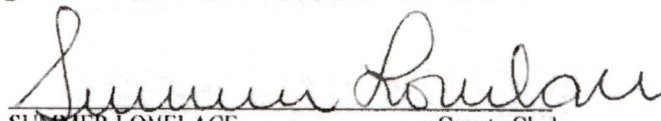
